### **Mattress** RECYCLING



- **1.** When you purchase a new mattress, ask the local mattress store to recycle your old one; or
- 2. For home pick-up of an old mattress, without the purchase of a new one, contact a hauler that will recycle your mattress; or
- **3.** Take your mattress to the Residential Drop-off area at the County Landfill for a fee or contact Hilltopper Refuse & Recycling at 608-783-6727, to find other drop-off locations.

## Styrofoam NEWE Recycling



New in 2024! The Department, in partnership with Hilltopper Refuse & Recycling and 7 Rivers Recycling, will be accepting Polystyrene (Styrofoam) foam for recycling. Standard disposal fees apply if dropped off at the landfill drop-off site.

### Landfill Fees All items dropped off will have a fee

#### Residential Drop-off Area: \$5 minimum or a \$120 per ton

- Garbage (normal household waste)
- Large Items (furniture, toys, bikes, stoves, grills, washers, dryers)
- **Demolition/Constuction** (wood, drywall, flooring, roofing, doors, windows, etc.)

### **Processing Pad:** \$5 minimum or a per ton fee

Landfill: \$15 permit fee and \$64 per ton

### **Mattresses & Boxsprings:**

- Recycled: \$12 each + weight
- Landfill: \$18 each + weight

### Freon Items: \$12 plus weight

Brush/Clean Wood: \$35/ton (wood that has not been painted, stained, or treated)

- \$1.95 on \$66.12 or less
- 2.95% on \$66.13 or more


Only people authorized by site attendants may utilize the landfill facility. You must provide your own labor for unloading materials. Due to safety concerns, we do not permit salvaging once waste is placed into containers.

### PLEASE READ SIGNAGE

The Landfill's address is 3240 Berlin Drive. The diagram to the right illustrates the entrance to our facility (the landfill is the second right on Berlin Drive). The landfill entrance is equipped with inbound and outbound scales - all landfill customers must scale in and out. Department staff are available at the scale to direct you on disposal options and collection of payment.

For mailing, billing, and other departmental questions our office is located at 3200 Berlin Drive (first right on Berlin Drive) and parking is available on the south side of the building. We can also be reached at (608) 785-9572.

# Town of Campbell Recycling of Yard and Garden Waste, Brush, Large Items, Appliances & Burning

This information is for single-family to 4-unit dwellings only. If more than 4 units, please contact your current hauler.



### **Please Review Carefully for Updates & Changes**


### Curbside Brush Chipping ( A & on calendar)

These guidelines are provided to efficiently streamline brush chipping services for Town of Campbell residents and our maintenance department staff. Small sticks and yard waste clog the chipping machine, causing delays and safety concerns. Brush chipping is **ONLY** intended for the disposal of small amounts of limbs/branches that are removed by residents for normal tree maintenance and upkeep. Brush must be from a Town of Campbell resident's yard. Brush transported from other locations is not entitled to brush chipping. Brush will be accepted from single family and 2 – 4-unit dwellings only.

Brush chipping is not provided for lot clearing activities or from the removal of trees or bushes. Contractor-cleared brush or trees will NOT be picked up whether FREE or PAID FOR. It is the contractor's or resident's responsibility to dispose of this. Residents must use the county landfill or tree service businesses for this type of disposal. Sticks smaller than 3/4 inch diameter and garden waste must be deposited at the yard waste facility behind Town Hall.

### ACCEPTABLE BRUSH IS DEFINED AS HAVING A CUT END LARGER THAN 3/4 INCHES TO A MAX OF 6 INCHES IN DIAMETER

Brush piles are limited to a size of 8 feet long and 4 feet high with a length equal to the uncut piece. Brush must be <sup>3</sup>/<sub>4</sub> to 6 inch diameter and left as long as possible to avoid machine clogs. Keep remaining brush in your yard until the next pickup date. Leave loose, no bundling. **DO NOT** put on curb until 3 days prior to your pickup date.



The maintenance crew will answer any questions you may have while they are at your residence. If you are unable to speak with the crew, please call the maintenance department with questions at 608-783-0050, ext 3.

**Schedule:** Brush chipping will start the first Monday of the month for areas NORTH of I-90 and the second Monday of the month for areas SOUTH of I-90 from May to October. Chipping will continue throughout the week until completed. Town crews will only go by each residence ONE time each month.

- In order to maintain the schedule, brush crews **WILL NOT** return for special pickups
- All brush must be curbside by 7 a.m. on the day of your scheduled chipping. The Town will not pickup brush in alleys. Town crews will not cross or enter private property to pick up brush. Brush that is not curbside by 7 a.m. will not be picked up until the next pickup date.

• **Piling brush:** Guidelines must be followed. If brush piles do not meet guidelines, the crew will not chip.

Pile brush with the cut end toward the road, all in the same direction, and pile as loosely as possible (brush is easy to handle). **DO NOT** pile it in the road. **DO NOT** combine piles with neighbors. Branches/limbs over 6" in diameter will not be accepted. Smaller branches clog the machine, leave the lengths long. Pile brush away from mailboxes, telephone poles, etc. Brush must remain on your property. **DO NOT** pile it in any parks.

Stumps, root balls, roots, rocks, rubbish, construction material, dimensional lumber, metal, or yard waste **WILL NOT** be collected.

• Brush due to major storm damage: The Town will determine and announce emergency storm-related brush collections. Regular brush clipping quidelines will apply.

#### Yard & Garden Waste

The Town yard waste site will be closed from December 1 - April 1. Regular hours for the site are 7:00 am - 9:00 pm, 7 days a week

• We have our own drop-off site for your yard and garden waste. It is located behind the town hall. Acceptable items are grass, leaves, brush 3/4" or smaller and garden plants. Please do not leave yard waste in paper containers.

### Large Items/Carpet

Please contact Harter's Quick Clean-Up, any refuse hauler, or the La Crosse County Landfill for disposal details and fees.

NOTE: Large items will be picked up by Harter's at no cost on: January 4, April 3, July 3 and October 2. Residents must contact Harter's directly the week prior to get on the list for FREE large item pickup.

ITEMS LEFT ON THE CURB WILL RECEIVE CITATIONS.

### **PFAS Water Filter Disposal Program**

Drop off your **point-of-use** carbon filters at Campbell Town Hall during business hours at no charge. **Point-of-enty** filters can be dropped off at the La Crosse County Household Hazardous Materials Facility at no charge. (HHM Facility on Recycler Front)

### TVs & E-Waste

TV's, computers (desktops, laptops, netbooks, tablets), desktop printers (including those that scan, fax, and/or copy, computer accessories (including monitors, mice, keyboards, scanners, hard drives, speakers, flash drives, modems), DVD players, VCR's, DVR's, fax machines, cell phones: Residents can take these items to the following places:

- 1) Harter's Quick Clean-Up (782-2082) (pickup service is available)
- 2) La Crosse County Landfill (785-9999)

Please call them directly for hours of operation, if any costs are involved and for questions concerning e-waste disposal.

### **Unacceptable Refuse**

### **Construction materials**

Items include: roofing materials, doors, bathtubs, shower enclosures, windows, sheetrock, brick, concrete, asphalt, kitchen cabinets, tarps, etc. Please contact the La Crosse County Landfill (608-785-9999) or Harter's Quick Clean-Up (608-782-2082) for details on how to dispose of these items.



### Hazardous materials

Cleaners, solvents, gasoline, oil, or other toxic, corrosive, explosive, or highly combustible materials may not be placed in the regular trash. Refer to the front page to see which hazardous materials are accepted at the La Crosse County Household Hazardous Materials Site. If in question, call the facility for a recommendation at 608-785-9999.

### Vehicle parts

Vehicle parts and other metal weighing 10 pounds or more will not be collected. Take such items to a salvage yard.

The Town of Campbell is using Automated Carts for refuse and recycling collection.

Two carts were issued to Town-serviced property; the blue cart with a green lid is for Recycling and the blue cart with a black lid is for Refuse. The carts have an identification number and are to remain at the address they were assigned to. Homeowners are responsible for replacement costs.

Please remember—it is illegal to dump trash, leaves, grass clippings, branches, etc. in any gutter along any public street, alley, or highway. [Ordinance 20-3 (A) ]. Placing these items in the gutter may create problems with our sewer system and may cause a backup. Your cooperation is appreciated.

You will receive a brochure like this at the beginning of each year, so please keep it! If you misplace it, please stop into the Town Hall to pick up a new one.

### Refuse (Black Lid)

Refuse is picked up on Tuesday. Trash should be placed in clear or semi-transparent plastic bags or placed loosely in your cart and placed out by 5:00 AM on your pickup day or the evening before.

### Recycling (Green Lid)

Recycling is picked up every other week. Do not place recyclables in bags; recyclables must be placed loosely in your cart and placed out by 5:00 AM on your pickup day or the evening before. The Town of Campbel utilizes a Single-Stream recycling system, which means all recyclable items can be placed in the cart together.

#### **PLASTICS**

- All plastics #1, #2, #4, #5 (must be labeled with the recycling symbol and #)
- Takeout containers, yogurt cups, ketchup/ mustard bottles, berry containers
- No packing peanuts or styrofoam
- Tubs, bottles, jugs, detergent containers

- Newspapers, shiny inserts
- Magazines
- Pressed paper, office paper, cardboard
- Toilet paper & paper towel cardboard rolls
- Cereal, cracker, snack boxes (not the plastic inserts)
- Soda, beer boxes
- Toothpaste, soap, detergent boxes

- Paper egg cartons
- Paper milk and juice cartons
- Mail, junk mail, etc.
- Cards, gift wrap (no tissue or foil paper)
- Corrugated cardboard (cut into pieces if it won't fit)

#### **METAL**

- Aluminum, tin, steel cans
- Empty aerosol cans, empty paint cans/lids
- Aluminum foil, plates, containers
- Christmas lights, extension cords,
- electrical wiring (no coaxial cable)
- Pots and pans

#### GI.ASS

• Glass jars and bottles (any color)

#### DO NOT RECYCLE THESE ITEMS

- Styrofoam
- Bottle or jar lids unless its #'d plastic
- Soiled paper plates
- Ceramics and dishware
- Windows and Mirrors
- Plastic wrap
- Photographs
- Shredded Paper, bagged or loose

#### RECYCLING TIPS

- All containers should be rinsed
- Remove all lids and if they're not marked with a recycling symbol throw them away

- Bags, newspapers and office paper should be thrown loosely into the recycling cart; do not bundle
- Break down the cardboard and pressed paper materials to make more room in your recycling cart

Disposable plastic bags (those typically given out at grocery stores or other retail outlets) are **NOT** to be placed with recyclables in the Town of Campbell recycling system. These bags should be returned to a retail outlet that has a plastic bag recycling container.

NOTE: Heavier recyclables should be placed at the bottom of the bin and lighter recyclables such as cardboard should be placed at the top.

#### REASONS FOR MISSED COLLECTION

- Cart is not placed out correctly
- Recycling is placed outside the cart or in a different container
- Cart is overflowing, lid does not close
- Cart was placed on a snow bank; they must be placed on a level spot on the boulevard or on your driveway
- Unacceptable items are in the cart (refuse items, appliances, electronics, hazardous waste, etc.)

### WINTER TIPS

- Clearing snow after each snowfall will make it easier to move your cart to its collection point
- Clear a path from your storage location to your collection point
- Clear a path at your collection point so carts sit flat
- Carts will NOT be collected if placed on a snow bank



### PLACEMENT GUIDELINES DO NOT PLACE CARTS IN STREET

- Make sure the arrows on the lid are pointing out toward the alley/curb line
- Cart needs to be at least 3 feet from any fixed objects, such as mailboxes, trees, streetlights, or parked cars and must have a 3 foot gap between the carts.
- Place them at the end of your driveway if possible or in the boulevard area, within 1 foot from the curb line.
- Position the cart on as level of a surface as possible, away from overhanging tree branches.
- The cart lid needs to be closed

### Household Hazardous Materials Facility (HHM)

Free for La Crosse County, WI residential users (unless otherwise noted below)
Houston County, MN and surrounding counties (Fees apply to all acceptable items)

### **Acceptable Materials**

- Automotive fluids
- Batteries (rechargeable, lead acid, lithium)
- Cell phones and digital cameras
- Cleaning products
- Computers (desktops, laptops, tablets)
- Computer peripherals (fax machines, hard drives, keyboards, mice, printers, scanners, speakers)
- Fluorescent light bulbs
- Lawn and garden chemicals
- Medications (non-controlled only)
- Mercury-containing devices (barometers, thermometers, thermostats, etc.)
- Microwaves and small Freon appliances Fees Apply
- Paints, stains, varnish and solvents
- Pool chemicals
- Propane cylinders (20# and under)
- Sharps and needles
- Smoke detectors
- TVs and computer monitors Fees Apply
- Vape pens/E-cigarettes
- Video devices (cable and satellite receivers, DVD players, gaming consoles, VCRs, etc.)
- Water filters (Point of Contact)

### Non-Acceptable Materials

- Compressed gas cylinders (other than propane)
- Controlled substance medications
- Explosives (inc. black powder, fireworks, military munitions, and flares)
- Shock sensitive materials (picric acid, etc.)
- Radioactive materials

### SAVE YOURSELF A TRIP!

These items can and should go into your regular curbside trash or recycling:

- Alkaline batteries (trash)
- Dried out paint (trash)
- Empty paint and aerosol cans (recycle)
- Fertilizer without pesticide (trash)
- Ice melt and rock salt (trash)
- Incandescent light bulbs (trash)

### **Preparation & Transportation**

### **Residential Drop-Off Hours**

Monday - Friday (year-round): 8:00 a.m. - 4:00 p.m. 1st and 3rd Saturdays (April - October): 9:00 a.m. - Noon

Businesses and organizations by appointment only.

Fees apply to all items for residents who live outside of La Crosse County.

### FREE PRODUCT REUSE ROOM!

Over 80,000 pounds of useable household products are sorted and made available to the public in our Reuse Room annually. All items are free, but donations are appreciated. The Reuse Room is open Monday – Friday from 8 AM to 4 PM. The Reuse Room is located on the east side of the landfill office building, directly adjacent to the HHM Facility.

### **Safe Transportation of Hazardous Materials**

- 1. Never mix chemicals.
- **2.** Bring items in original containers or clearly mark contents. Tell facility technician if you are unsure what is in a container.
- 3. Tighten all covers and lids.
- **4.** If a container is leaking, pack it separately in a leak-proof pail or tub.
- **5.** Avoid spills. Place waste containers upright and place securely in the trunk or back of a truck or van. Do not transport waste containers in vehicle passenger areas.
- **6.** Gasoline should be transported in a designated red safety container.



7. Motor oil should be transported in a durable and leak-proof container labeled with the words "Used Oil."

- **8.** Tape the terminal ends of batteries with clear tape to prevent arcing. Do not co-mingle batteries with chemicals.
- **9.** Transport fluorescent bulbs securely to avoid breakage. Do not tape bulbs together.
- **10.** Upon arrival, pull under the HHM canopy and remain in your vehicle with the engine shut off.



- Needles, syringes, auto-injectors (EpiPens) and lancets must be transported in sealed, puncture-resistant containers.
- Container options include a standard red sharps container or a thick plastic laundry detergent bottle with screw on cap. All containers must be labeled with the word "SHARPS."
- Additional sharps collection sites can be found on the Alliance to HEAL website.
- For after-hours service, a red sharps drop box is located on Berlin Drive at the La Crosse County Solid Waste Department entrance. This drop box accepts single-use needles as well as small sharps containers. (see map above)
